#### Selected Case

Lee v Parker (No 2) [2022] FCA 582 - (led by C Wood SC) Successfully opposed an application for security for costs.

**CLGC Pty Limited v Zhang [2021] NSWSC 946** – (led by C Webster SC) Successful claim for damages against a former solicitor, including for breaches of fiduciary duties. Judgment obtained for a sum in excess of \$15m.

*Hassan El-Jamal [2021] NSWSC 114* Judicial advice relating to an application for sale by a trustee.

*Fisk v Gold [2021] NSWSC 1465* Contempt application before Ward CJ in Eq- Successfully obtained an order for costs payable on an indemnity basis, forthwith.

Numerous other decisions, such as a \$2.2m judgment on behalf of the DCT in the Federal Court (DCT v Hawach), and successfully capping receivers fees in the Supreme Court, and dissolving a partnership (Shanmugathaas & Anor v Paramanirupan), as well as countless matters resolved without a final hearing, including numerous insolvent trading, unfair preference and uncommercial transaction cases, numerous building and construction disputes, and numerous matters for and against the ATO and Revenue NSW.
